#### 1. Welcome

# 3. General Manager's Report

### 4. Financial Statements

Barry said that the year-to-date numbers were close to plan. The Board discussed the following points from the Financial Statements:

### Cash in Bank - Term Deposit

There was currently \$260,000 sitting in the bank.

It was resolved that \$100,000 of that amount be moved to a 6-month term deposit.

### Cash to Purchase Prizes for Open Events

Currently two signatories were required to withdraw cash to buy prizes for open events.

**It was resolved** that an imprest account be opened, with a maximum of \$2,000, to enable the General Manager to purchase prizes, and that an ATM card be linked to that account.

### 6. Hardship Policy

The Board took up Barry's offer to bring to the April meeting a draft Hardship Policy, for discussion and ultimate adoption. The policy should be based on the Bowls New Zealand policy, which caters for a one-off significant adverse event in a club.

The Board asked that the proposed timeline be brought forward by 2 weeks to allow more time for clubs to consider the matter, and felt that it was not necessary for the Competitions and Tournaments Manager to be involved with the committee.

#### 8. Greens Allocation

The Board discussed the issue of the way in which greens are allocated for tournaments. Greens were allocated early, and not checked closer to tournament time. Often they were substandard. It was suggested clubs be advised that, in future, greens will be rechecked by a small group of people, including someone from the Greenkeepers Association, 4 to 6 weeks before a tournament is due to be held.

#### 9. Other Business

### Wellington Masters

Nominations for the Masters closed last Friday, and were sent out on Monday. The Board discussed the cost of having two teams (Hutt Valley and Wellington) for men's and women's tournaments.

It was resolved that, from the 2023-24 season, there be one men's team and one women's team for the Wellington Centre.
