1. Welcome and Agenda

The Chair welcomed everyone to the meeting.

2. Obituaries

The obituaries had been noted in the Delegates' meeting preceding the Annual General Meeting, and a minute's silence observed for Peter Strange (Tawa Services), Bob Crawford (Naenae), Chad Morehu (Naenae), Sharon Nixon (Petone Central), Paddy Breslin (Petone Central), and Harry Kerr (Upper Hutt).

3. Confirmation of Minutes of 2019 Annual General Meeting

It was resolved that the minutes of the Annual General Meeting held on 30 July 2019 be confirmed as a true and correct record of the meeting.

4. Presentation of Annual Report (2019-2020)

The President spoke to her report. She highlighted the following:

- The COVID-19 pandemic and lockdown had meant the end-of-season tournaments had not been held. She congratulated clubs on adhering to the recommendations and for checking regularly on members' welfare.
- Thank you to the General Manager for his excellent work during the year and his interest in clubs. Clubs had gained a lot of benefit from that.
- The Bowls3Five competition had increased locally this year, with the introduction of regional teams. Twenty-seven teams had entered, including two Wellington teams, and

Stokes Valley had got through to the finals. Also, it was great to watch Stokes Valley perform each week on television.

- Thank you to the Tournament Controllers, the Umpires' Association, and the Greenkeepers' Association for their work and support.
- The ability for all bowlers to watch the live-streaming of bowling was further progress.
- The Board had met six times during the year, and continued to work to bring about the best happenings for all bowlers and supporters.
- Former Board Chair, Mark O'Connor, had been appointed President of Bowls New Zealand.
- The Board had farewelled Wayne Henshaw (Vice-President for the past 2 years) and Mark O'Connor and thanked them for their work.

The Board Chair said she was extremely proud of Bowls Wellington and all the clubs in the area, especially for keeping things going during the lockdown. She reiterated the thanks expressed by the President, and wished everyone well for the new season.

The General Manager highlighted the following from his report:

- Thank you to all clubs and their Executives for their support of Bowls Wellington in its attempts to continue to provide playing opportunities.
- Thank you to the Board for their support, and the umpires, tournament managers, and greenkeepers for their work. But there was still more work to be done!
- Funding had been secured for a series of workshops designed to assist clubs in overcoming the challenge of getting more people bowling.
- The Champ of Champ Finals weekend will be an opportunity to showcase the competition through live-streaming, Facebook, and the website.
- Free entry for Junior 1-3 players in open tournaments will be trialled. Clubs are encouraged to engage with and welcome their juniors.

It was resolved that the Annual Report for 2019-20 be accepted.

5. Presentation of Annual Financial Report (2019-2020)

The General Manager said that, unfortunately, the Bowls Wellington Financial Reviewer, Ken Brown, had stepped away from the role. Shayne O'Hagan of Small Business Accounting was available to do the financial review this year.

The Financial Report showed a small surplus for the financial year and that Bowls Wellington was slowly becoming a sustainable organisation, able to withstand an event such as COVID-19 and what it will do to class 4 gaming. Efforts will continue to build cash reserves.

President's Report 2020-2021 Season

This past season has seen Bowls Wellington achieve many initiatives mainly set up by our General Manager Nigel Dixon and endorsed by the active Board members. Some highlights of the season include;

- The Champion of Champion Finals weekend which players and spectators thoroughly enjoyed. It also was great to see the smaller clubs finding success. We congratulate the clubs and players who won Champion of Champion national titles with Robbie Bird (Naenae) taking out the Singles and Helen King, Sarah Taukamo and Robyn Rintoul (Victoria) winning the Triples. Lisa White and Lil Renata (Naenae) and Rob Ashton, Ross Gillett and Wayne Coleman (Johnsonville) finished 3rd in the Pairs and Triples respectively.
- The entry fee to Open events whereby Junior 1-3 Year players would pay no fee encouraged more participation with many experienced club bowlers including new players in their teams.
- The Bowls3Five competition in both Open and 1-5 Year had more teams and thank you to Key Housing who donated the Cherry Fulcher Cup for the Open competition.
- The Senior selectors named 40 players (20 Ladies & 20 Men) to participate in Winter training together at Naenae.
- Bowls Wellington supported the two Clubs who won the Wellington Interclub (Naenae women and Stokes Valley men) to travel to the National Interclub Finals in Christchurch both winning the Bronze Medals. It was a pleasure to go south and give support to both teams.
- The Secondary Programme increased, and several Clubs hosting the competitions between local schools. This has led to a Bowls Wellington Secondary School's Team being selected to participate in a lower North Island Quadrangular Tournament in Taranaki.
- Bowls Wellington introduced the inaugural Duke of Edinburgh Bronze Award to ten girls who
 worked over eight weeks learning the game, laws, and etiquette. The girls will complete the
 Award when they represent their schools in the Term Four competition. Bowls New Zealand
 is now encouraging schools throughout New Zealand of this initiative by Bowls Wellington.
- Wellington High School selected bowls as a new sport for a Recreational Credit within their examinations system. The players involved have all reached Excellence after a six-week programme.
- An opportunity for Clubs to further develop their administration skills was made available
 through the Bowls Wellington funded workshops. For those Clubs who attended, the wide
 variety of subjects allowed clubs to enhance their programmes or reinforce that they were on
 the right track.
- Communication with the members was regular and very informative allowing everyone interested in Bowls to know what was happening.
- The Bowls New Zealand Nationals in Central Otago enticed 85 Wellington bowlers to head south with much success. Nicole Toomey won the National Singles while Laurie Guy and Sarah Taukamo won the National Mixed Pairs. Leigh Griffen was recognized for winning five National Titles and received her NZ Gold Star. Wellington players reaching the last sixteen numbered 23 players. Congratulations to all.
- Players selected to represent the North Island, in a year when no International Bowls were
 played made the selections very important for the future opportunities. Congratulations to
 Seamus Curtin, Finbar McGuigan, Ray Martin, Clare Hendra, Nicole Toomey, and Dale Rayner.
- Our Senior and Junior Representative performed with distinction with six 1sts, one 2nd, two
 3rds in regional tournaments before the Senior Men and Women's side finished with bronze
 medals at the NZ Intercentre. Another representative event was played this season with
 Wellington taking on Manawatu. This is now a fixture on the calendar and provides a valuable
 warm up before the first tournament of the year.

- The Stokes Valley Bowls3Five Vipers in the televised competition gained the National Title. Congratulations to their players, a sterling outcome.
- The Bowls Wellington Open Centre Events increased in participation with numbers from all Clubs. With more variety and options now for participation, there is something for all types of bowlers.
- Gerry Macgregor was again fantastic as Tournament Manager and worked diligently throughout the season recording all the results and preparing the post section play-offs.
- The Mid Week competitions titles are fought for as fiercely as any competition and majority of clubs have teams in all divisions.
- The Umpires have worked hard to increase numbers this year and more have come forward to be tutored as umpires or measurers under the guidance of the tutors Peter Nixon, David Burrage and Anne Burrage. A special thank you to Peter Nixon who is retiring this year. The Umpires' have supported not only our local competitions but some Bowls New Zealand events with our International Umpires Michael Johnson and Sue Way overseeing, also showing the precision required at the top.
- The Greenkeeper's Association has kept up their work monitoring Greens and giving sound advice. We are fortunate to have such expert advice available to all.
- The Club Delegates have attended four meetings and the Annual General Meeting. The Tournament review now discussed fully in Clubs has meant these meetings are precise and as all delegates come to vote with the Club's decisions making the meetings more efficient and worthwhile.
- The Bowls Wellington Board met seven times to provide governance and leadership and have created a new Strategic Plan which is available on the Bowls Wellington website. This will guide the next 10 years for the centre. The Board continues to work conscientiously to ensure the best possible outcomes for our players and supporters.
- The employment of Ross Gillett to the Office has allowed Nigel to focus on governance, growth, new programmes, and funding.
- The closure of the Workingmen's Club this season which began 65 years ago was a loss, but the few members joined with Newtown. This arrangement has certainly increased the interest in bowls in the Newtown area.

Clubs you are the backbone of our sport and you all have certainly played your part this season. Our sport now has more opportunities to reach the public and your great work with corporate groups, encouraging the community and being readily available can only enhance our game. Keep up the good work and continue to grow.

A great first of many. It was a huge weekend of great bowls and camaraderie.

With the threat of Covid coming to our shores at any time, we have to remain flexible and take the opportunities when we can to enjoy the sport we all love.

General Manager Report

We started the 2020-21 season with much anticipation and excitement, yet under a cloud of Covid uncertainty. The effects of the pandemic were yet to be known, and with further lock downs possible, no one knew what lay ahead. It is a credit to all in our bowling community that our sport could push this uncertainty, and enjoy a hugely successful season both on and off the green.

From a Bowls Wellington perspective, we were delighted to welcome onboard Ross Gillett as Competition and Administration Manager. His experience and skill set has been a huge asset to the organization. Thank you to our outstanding Board – Sue Way (Chair), Dayle Jackson (President), Gerry Macgregor, Rod Leitch Sharman Buckle and Jason Puddick for their leadership and governance, and also for the various portfolios they manage.

Encouragingly, we saw growth in participation rates across most Centre tournaments, particularly amongst women which bodes well for the future. 59 Junior 1-3 players (total 100 entries) took advantage of free entry into Wellington open events, reducing some of the barriers for new players to our game. Interclub and Pennants entries also showed incremental yet positive growth, which is starting to arrest decades of decline. Bowls3Five continues to grow in popularity, where we saw explosive growth from 27 to 65 teams over the previous season.

This past season we also saw the introduction of the Champion of Champion Finals weekend which brought all our semifinalists together over two days for a great spectacle of bowls, creating a fantastic atmosphere and a real showcase event for the region. This event was also the first time Live Streaming was introduced for Bowls Wellington events and it was great to see people tuning in, not only from around the region but around the country and overseas.

With a greater focus on the school and youth space, Bowls Wellington partnered with the Duke of Edinburgh Hilary Award, working with students from Chilton and Sacred Heart towards their Bronze Award. This pilot programme has garnered the attention of Bowls NZ and other centres who are now looking to replicate the programme nationally. The Thursday CSW competitions continue to be a great opportunity to introduce high school students to the game and we thank those clubs who host on Thursday afternoons. Additionally, the Term 1 and 4 School tournaments and the new School Representative programme provide another opportunity for those who wish to engage with the sport at a more competitive level. We look forward to continuing to working closely with schools and students to cultivate and foster an appreciation and love for the sport which will see them come into our clubs when the timing is right for them.

Although we couldn't get an outdoor winter competition up and running, Naenae was gracious in permitting the use of the Indoor on Wednesday mornings for the inaugural WinterFours. Although heavily promoted through club secretaries and executives, the Bowls Wellington Digital Newsletter, Website and Facebook, numbers were initially disappointing. However, with some tweaking of the format, the first iteration of the competition was a success and I'm confident this will grow in future years.

This coming season, we are looking forward to building on the foundation of the last couple of years with further new initiatives targeted at driving growth and improving the playing experience. I'm particularly excited about the new Bowls3Five Premier Tournament and modified Twilight Bowls3Five competition, and the launching of the 'Bowls Wellington Supporter's Club', amongst other exciting plans which are designed to keep our sport relevant and competitive in an extremely competitive and saturated recreation market.

Finally, I would like to say thank you to all our volunteers who enable us to function and succeed. Although too many to name herein, please accept my, and Bowls Wellington's, eternal gratitude for the work you do. Thank you to our Representative Selectors, the Wellington Umpire's Association and Wellington Greenkeeper's Association, our commercial partners and funders, clubs and their executives, all our volunteers and to all our friends and supporters in the community. We look forward to once again serving you and the bowls community in the season ahead.


